ARTIFLE 16: AFFILIATED STATE/U.T.TAEKWONDO ASSOCIATION MEMBER UNITS BOARD – DUTIES.

- 16.1 State Associations / Member Units must abide by the Constitution of TFI.**
- 16.2 State Associations / Member Units who will not follow with Constitution of TFI will be issued a Show cause notice. Even after the service of the notice the defaulting State Associations fails to adhere to the constitution, the state association will be kept under suspension.**
- 16.3 State Associations / Member Units must conduct State Championships every year in all the divisions-Sub-junior, Junior, Senior for both men and woman (Colour belt) & Senior for Male Black Belt. A detailed report consisting of the results, number of participants, number of Technical officials, details of upcoming players must be sent to the TFI Secretariat. TFI shall depute an observer for supervising the Championships.**
- 16.4 Notification indicating venue, date and time for elections should be intimated by the affiliated State Associations to the TFI Secretariat 15 days before the elections. The list of authorized representatives shall also be forwarded to TFI.**
- 16.5 To ensure free and fair elections the TFI shall depute observers to the elections of office bearers of all affiliated State/ U.T. Taekwondo Associations. All the records must be placed before the returning officer as well as the TFI observer.**
- 16.6 Elections held by affiliated State/U.T. Taekwondo Associations without intimating to TFI and in the absence of TFI observer will be treated as null and void.**
- 16.7 Appeal against any such election shall be made to the President or the Secretary General of TFI within 15 days of the elections held. The President or the Secretary General of TFI shall get the matter looked into expeditiously and decide the same within a period of 30 days.**
- 16.8 State Associations / Member Units shall furnish a report to the TFI Secretariat stating number of district associations affiliated under State/U.T. Taekwondo Association. TFI will honour outstanding Instructor who has produced more than 200 applications for Identity Card, 200 candidates for Belt Registration and 10 qualified Black Belt Dan Certificate in their District/Club annually. Notification indicating the name of the outstanding Instructor should be**

intimated by the affiliated State Association/Member Units to the TFI Secretariat 30 days before the National Taekwondo Championship for awarding.

- 16.9 The TFI will honour top-3 rank (1st, 2nd & 3rd) position to the member affiliated State Taekwondo Association/Units whose submit maximum application for I.D.Card, Belt Registration & Dan Certificate annually, at the General Body meeting of TFI time to time.
- 16.10 State Association / Member Units shall deal with all matter through TAEKWONDO FEDERATION OF INDIA, as the case may be.
- 16.11 State Association / Member Units shall submit Marksheet as well as belt registration records and apply Identity Cards for Trainees by bi-monthly.
- 16.12 State Association / Member Units will not take part in any Event or conduct the activities of Taekwondo after getting them duly approved by the TFI.
- 16.13 State Association / Member Units shall submit I.D. Card Fees and Belt Registration Fees time to time.
- 16.14 State Taekwondo Association / Members Units shall include Technical Director appointed by TFI as ex-officio of the concern State /U.T. Organization /Units members Taekwondo Associations as provisional in Article 4.5 of this Constitution.
- 16.15 That the Sate Taekwondo Association / Member units shall submit Annual Affiliation Fee in the month of March each year. Refer to Article 5.2 for more details.
- 16.16 That in case of intentionally/deliberately violation of any of the aforesaid term and conditions / Rules & Regulation / Constitution of the TAEKWONDO FEDERATION OF INDIA. The affiliated State/U.T. Taekwondo Association and members Units who so-ever shall be treated as withdrawn/de-affiliated/debarred to take part in the activities of TFI without notice.
