ARTICLE 8 : EXECUTIVE COUNCIL (MANAGING COMMITTEE) :

- 8.1 The following Officers and Members of the Executives Council shall be incepted at the TFL**
- a. President.**
 - b. One Vice President (Headquarters)**
 - c. Ten Vice Presidents.**
 - d. One Secretary General.**
 - e. One Treasurer.**
 - f. Four Joint Secretaries (Administration, Planning, Development, and Co-ordinating).**
 - g. Ten Executive Members.**
 - h. Life Members (They will not be entitled to vote).**
 - i. Patrons (They will not be entitled to vote).**
 - j. One legal advisor (He will not be entitled to Vote).**
- 8.2 Ordinary Meetings of the Executive Council shall be held once every six months at 30 days Notice . Extra ordinary meeting can be convened by the President TFI , if considered necessary , at a notice of 10 days. Notifications for meetings may sent by letters or by telegram as considered expedient.**
- 8.3 The term of office of the existing officers/members of the Executive Council shall ordinary be four years , but shall be deemed to have been automatically extended to the requisite extent, if fresh election do not take place for any reasons.**
- 8.4 If a vacancy is caused on the post of an Office Bearers in the Executive Council, it shall be filled up for only rest of the terms, through nomination by the president TFI on the advise of the Secretary General. In case the post of the President falls vacant the provision of Article 9.2 shall apply.**

- 8.5 The Office Bearers shall hold office as individual and not representative of State level Organization / Association. Accordingly in case, an Officer/Member of Executive Council resign or cease to be in office due to death or dismissal by the Executive Council , the vacancy shall not necessarily be filled up by another individual from the same State/Union Territory./ The vacancy shall be filled up for the rest of the term only through the nomination by the President. If an Office Bearer ceased to be a member of the State Association due to any reason, during the currency of it's term as Office Bearer of TFI, he will continue to complete his normal term with the Federation.**
- 8.6 The elected members of the Executive Council are eligible for re-election. Each term of office shall be four years. The Office Bearers may hold their respective posts , as such , for one term of 4 years and may be eligible for re-election for another term.**
- 8.7 The Executive Council shall discharge the following functions:**
- a. Planning and management of the TFI Organisation and its operations.**
 - b. Management of the financial affairs of the TFI**
 - c. Processing of the proposals for amendments to the constitution, Rule & Regulations.**
 - d. Formulation and enforcement of Rules & Regulations for conduct of elections and other administrative and operative functions.**
 - e. Preparation of Agenda for General Body Meetings.**
 - f. Matters referred to it by the General Body.**
 - g. Other matters relative to property of the TFI welfare activities administration of the best etc.**
 - h. Delegation of authority to President, or other officers committee**
 - i. Proposal for appointment of Life members/ Patrons.**
 - j. Suspension and / or dismissal of a member of the Executive Council.**
 - k. Talking disciplinary action for misconduct, misbehavior or any other offices or lapses against any affiliated association or any member of Taekwondo Authority.**
 - l. Appointments of consultative and other Sub - Committee.**

- 8.8 The Executive Council shall be competent to impose the following sanctions against offences by member states or individual for misconduct, un-sportsmanlike behaviour and act of violence any other offences or lapses :**
- a. Warning**
 - b. Punishment with fine.**
 - c. Rebuke or condemnation.**
 - d. Suspension of membership.**
 - e. Expulsion and dismissal of member State/U.T Taekwondo and Office Bearer for reasons of madness , conviction by the Court of Law , insolvency or any misconduct.**
- 8.9 During any Zonal Level , National Level or International Level competition etc. any un sportsman like be haviour on the part of the sportsman /sportswomen, officials or coach, which includes a insulting, making undesirable gestures, abusing the decision of the judges/Referee and provoking the opponents or spectators etc. in a word , committing any act not in keeping with the propriety of sports shall be punished as follows :-**
- a. Disqualification for the duration of that activity.**
 - b. Disqualification for the entire duration of the competitions .**
 - c. Prohibition from participation in competitions for a fixed period of time.**
- 8.10 The decision of the Executive Council on the point under article 8.8 Sub Para d & e, shall be subject to ratification by the General Body in its following meetings.**
- 8.11 Monetary fines shall not exceed the amount of Rs 5000/-, (Rs five Thousand only).**
