### **ARTICLE 7 : GENERAL BODY AND ELECTION:**

- 7.1** At least one meeting of the General Body shall be convened every year at the Headquarters of the Federation. Additional meeting may be convened at the venue of the National Championship of Taekwondo or at any other place to be decided by the President on the advice of the Secretary General.
- 7.2** Extra Ordinary meetings of the General Body can be convened by the President, if consider necessary. In such meetings only the items circulated in the Agenda shall be considered.
- 7.3** For ordinary meetings, a notice of 30 days shall be required, Extra Ordinary meeting shall be convened, If necessary, at 15 days notice.
- 7.4** The date time and place of meeting shall be advised to all concerned by letter or by telegrams as considered expedient. The agenda shall be sent 20 days in advance for ordinary meetings and 1 week i.e. 7 days for extra ordinary meetings.
- 7.5** The General Body shall discharge following functions :-
- a.** Election of Officials.
  - b.** Amendments to the constitution, Rules & Regulations.
  - c.** Approval of the Statements of Income & Expenditure.
  - d.** Consideration of the schemes and activities of the TFI.
  - e.** Consideration of items put up by the Executive Council.
  - f.** Consideration of the applications for memberships of TFI.
  - g.** Consideration of items proposed by any member with the approval of President.
  - h.** To hold and control the funds and other properties of the TFI.
  - i.** Appoint Committees or Sub-committees.
  - j.** The sole in-charge of all Taekwondo matters in the Country.
  - k.** Complete jurisdiction over all matters pertaining to the participation of India in International Championships / Games.



- c. The right of exercising the vote shall vest in accredited representatives deputed by the Members. A representative, accredited by the Member unit, must be a member of that Association affiliated to TFI and would attend meeting in which elections are to be held on production of a certificate signed both by the President and the Secretary of the State/U.T. Taekwondo Association detailing him/her for attendance on their behalf. However, if a representative produces a certificate signed by the President and another representative from the same Association produces a certificate signed by the Secretary, then the Secretary General of TFI will decide the authentic person/representative for the meeting of TFI.**
- d. Voting, if necessary, for the elections of the Office Bearers and Executive Council members, shall always be by Secret Ballot or as decided by the General Body.**
- e. The right of exercising the vote shall vest in accredited representative deputed by the Members. One and the same person shall, under no circumstances, be entitled to represent more than one Member Unit.**
- f. Each affiliated Member Unit shall be entitled to two votes. Each authorised representative deputed by Member Unit shall be entitled to one vote.**
